Mr. Mitch: Any questions or comments from Council?

### **Public Meeting:**

Council President Small: Thank you Mr. Mitch. I am now going to open the public session of the meeting, please state your name and the part of town you live in. You have a five-minute, one-time period to speak.

James Dabrowski, Woodbridge: Commented on Council President Small, James Nolan, Esq., and the late Civil Rights icon John Lewis, how he worries about the lack of transparency and accountability in Woodbridge, and on Peter Fenn quote: "A basic tenet of healthy democracy is open dialogue and transparency." Spoke in favor of other towns council meetings in New Jersey, and how their mayor and council engage in virtual meetings. Spoke not in favor on how Mayor McCormac is missing the council meetings and the Human Rights Commission meetings after the Woodbridge Youth for Liberation and Equity began advocating for anti-racism. Thanked Councilman Anderson, Councilman Ficarra and Councilwoman Drumm for attending the Human Rights Commission meetings. Talked about Councilwoman Drumm and her Facebook Post, Black Lives Matter, his position towards the resignation of Woodbridge Police dispatcher Marc Repace, the wrongful incarceration of Najeer Parks, the Civil Rights lawsuit against Woodbridge Township, the lack of acknowledgement on the Woodbridge Township website to celebrate Black History Month, how a white man is promoting his book about slavery at the library, the discrimination assessment, and how the Woodbridge Township should commit to anti-racism.

Council President Small: Time is up.

Victoria Bertsch, Colonia: Spoke in favor to more candid and open conversations with the town on Black Lives Matter. Wished a Happy Black History Month to everyone, questioned if anyone is reading on any fun black authors for this Black History Month, and commented how she is tackling James Baldwin.

Kason Little: Commented on the last meeting he attended to, how disrespectful was that Council President Small turned his back on him, and questioned "why are you still sitting there?" He spoke about his failure to address racial justice, and how law enforcement racially profiles innocent, unarmed black people, such as his relatives while driving through their city and how officers tell them that they just look suspicious because they are black. Addressed how black people is born black and die black, can't wash off their skin color, and has to prove their humanity over and over in this township. Asked Council President Small to resign ashamed and spoke about how his power should be taken away, the nepotism, and cronyism. Talked about how they all should be ashamed of themselves, to be on the right side of history, how justice should be served, to put themselves in black people shoes, how this is hurtful for black people who are gun-down by a police and how they can't find the statistics that prove that black people are disproportionately affected by law enforcement or crimes today such as Breonna Taylor, George Floyd, Trayvon Martin, Eric Gartner, Sandra Bland, Ahmaud Arbery, Amir Johnson, and Maurice Gordon. Commented on how nothing it's being done to remediate this, and asked them to be sympathetic and act on black people's best interest. Said that he will continue to show, speak what he has to say, and pray for the young people watching to gain the courage and lead against them.

Reverend Donna Stewart, NAACP: Thanked for the opportunity to speak, thank to those who have the courage to speak, and commended Councilman Anderson for being recognized by the Middlesex County Democratic Organization Black Caucus. Brought reference to the book Caste the Origins of Our Discontents written by Isabel Wilkerson, "A Long Running Play and the Emergence of Caste in

America". Commented that she was on the call on Saturday, as well as Speaker Coughlin, Mayor McCormac, and Councilman Anderson who received an award from the Middlesex County Democratic Organization Black Caucus, and said that she was offended by what the Mayor said to him. Reminded how everybody's child or nephew will not always be watched by them sitting there and in this town, and that they will end up working for somebody else. Lastly, she asked them to take into consideration what they say and how they act on the things that are going on in this community and in this world.

Council President Small: Thank you.

On this day in 1923, Bessie Smith made her first recording of "Down Hearted Blues", sold 800,000 copies for Columbia Records. 1951, the New York City Council passed a bill prohibiting racial discrimination in city assisted housing developments. On this day in 1957, actor Levar Burton was born and on this day in 1970, Joe Frazier knocked down Jimmy Ellis to become the world heavyweight champion.

On February 28th, the Independent Club of Colonia will be holding a Black History Month virtual celebration, so that would be Mr. Phillip L. Hall and members of the Independent Club of Colonia.

I would like to thank Reverend Donna Stewart for her acknowledgment, and apologize for not being able to get on her call yesterday. But if she is wearing African garb that was the theme in yesterday's NAACP meeting. And I believe that there were some people on that had a nice celebration, and so forth. So I want to commend you on putting that together.

And I do obviously want to thank Middlesex County Democratic Organization Black Caucus and Sheriff Mildred Scott, for selecting me this year as the person of Black History Month. This is my 10<sup>th</sup> year as a councilman, and you know, it was a good time, well-timed, something that I did appreciate. So it is always awkward asking people to come and celebrate you, but this one I really appreciate.

On Wednesdays, for the next two Wednesdays, Middlesex County has been having story time for Black History Month for ages 2-10 at 4:00 p.m. So tomorrow at 4:00 p.m. and then the following Wednesday at 4:00 p.m., You go into the Arts and Culture Page of Middlesex County and students from New Brunswick High School have been leading Arts & Crafts, Storytime for all students and it's really been nice to see the High School students working with the kids age 2-10, and a lot of the kids don't want to go off the Zoom call. They're really enjoying and they want to show their artwork. So, I encourage you if you have some kids that age, to take your time. And I enjoy it. I just put it on while I am working and watch what the kids do, and then at the end, I just compliment their artwork.

I would like to thank Councilwoman Meehan for putting the Food Drive together. There were very important volunteer hours for our Middle School students, and two in my house, my twin boys went

out and froze their tails up. Councilwoman Meehan took care of my boys, and I thank you very much for putting that together.

And lastly, for Black History Month. I want to share with you a 1952 article from Ebony Magazine called America's Oldest Negro Community. My family started this community, all right. Pre-Revolutionary War and this is in Gouldtown, New Jersey, and this is probably the first site of the first interracial marriage. This is a fully sustainable town. It is funny because there is a picture of a guy that could be my uncle. But John Fenwick, who was a nobleman who came from London or England, and was with the Quakers, came here with his granddaughter and a laborer named Gould. And the laborer happened to be a black man. Well, his granddaughter fell in love with him. They were cast off with scorn and ridicule, but they started a community in near Bridgeton that is called Gouldtown, New Jersey. It still exists and John Fenwick is the founder of Salem County. So back then it was considered West Jersey. But this is a very interesting article and my family, my mother's maiden name was Wrights. There were a thousand persons bearing the name Pierce, Murrays, Cuffs and Wrights. I came from the Wrights, but this was a very interesting article, 1952 Ebony Magazine. It started right here in New Jersey and I am a direct descendant of that family and I am very proud of that. Thank you. That's all.

And for the older group, if you are a person that enjoys playing golf, they do have a state-of-the-art golf simulator at the Club at Woodbridge and it is a lot of fun and a good way to recreate.

Councilman Ficarra: I would like now to move over to some of the Mental Health initiatives that I've been speaking about the last couple of weeks. Just to give you an update of where we are at now. The police will be receiving training in sensitivity to a range of disabilities including differences between cognitive and development disabilities versus behavior, health issues, including substance abuse disorders. Police will be trained in de-escalation and available resources via Captain's Penna, training session that was recently approved I believed by the attorney general, that was a hold up. I mentioned our relationship with Specialized Case Management Outreach Services which is called SCMOS for short. The last time I spoke, we were in negotiations with them; those negotiations are completed, and the pathway for how we communicate with them has been established. The Police Department will be establishing their point person that will be responsible for implementing the program and also for maintaining compliance. Relationships with Rutgers Acute Psychiatric Services - emergency 24/7 have been established, Raritan Bay Medical Center have been established, sub-acute and chronic behavioral illness with Rutgers Early Intervention Program has been established, and we clearly have a point person, again in SCMOS, Stephanie Evans who heads up that department. I appreciate the update from the administration, and Dr. Nolan who is our representative on this end.

13. COVID-19 efforts.

Councilman Ficarra: Moving down the agenda to some of the Covid updates, which seem to be heavy on everyone's mind. During this past week, February 7th – 14th, there were 4 Clinics held and during that time 664 more doses were distributed. So that total is at 17 clinics, 2,347, and that sounds wonderful, but when you consider we are a town of 100,000 plus, that doesn't really put a dent in things. But that is not a lack of our desire to do that. When we get the vaccines, we are quick to distribute them. Doses are limited. Now, I think, most of us are hearing that CVS and Rite Aid are now giving out vaccines. That's Federal Government controlled directly to them. So if you are a customer of either of these two CVS or Rite Aid, I suggest you reach out to them. I just called Walgreens, they said yes, but they don't have them yet. I did that because that's where I go. But I mentioned this in a different meeting last night. I think, initially three weeks ago, when I asked to be updated on this to present to the public, the battle cry was to sign up on the New Jersey website and wait your turn. That's the best way to do that. Based on recommendations from a number of people in the medical profession and here, I think the best recommendation is whatever website you can get on, whoever you can call, call, and be relentless about it. There is a 211 number. That is a 24/7 number that can give you general answers to questions about Covid-19. There is an 1-800 number 962-1253 about medical information, and when you call that number you are speaking to healthcare professionals. If you have medical conditions and you are wondering how it might be affected by getting the vaccine, these are medical professionals that answer this phone, but needless to say their scope of work is large and long. Please be patient if they don't pick up right away, but it is 24/7. So now the Covid website for the state, it is covidvaccine.nj.gov. I still recommend that you sign up on that. And by the way, if you have senior folks that are neighbors, and that they don't have a computer or they are not comfortable with a computer, you can register for them. And if they get called, the notification will go to your email if they don't have an email. Or you can call our senior services at 732-726-6264. Those are the Woodbridge angels that are helping out anyone that needs help. They will actually help you register right on the phone, and we've gotten great compliments on them.

The Edison mega-site has its own website, rwjbh.org that is RWJBarnabas Health, and that is just exclusively for that. Middlesex County has its own information. Middlesexcounty.nj.gov/covid19. Again whatever you hear, register for it and if you have any questions call 211.

And just to closing I would like to point out that in Resolutions today, we passed about \$185,000.00 in resources from our Community Development fund - the Grants to Catholic Charities for family day care, so families that need day care, they can go back to work, family and youth counseling, the Ozanam Family Shelter for homelessness through Officer Mark Zeno, and our new Department of Aging. We have now a relationship with the Code Blue system with the temperatures or the weather. The County calls a Code Blue, and there is a shelter in Perth Amboy that is run by the YMCA that we have established a relationship with, Officer Zeno is the point person on the PD, and we have direct access now that we can call, we can take people that might be unfortunately without a home and on the streets to safety, and then once they are there, they can be signed up and put into services that may be able to assist them. So there is some nice progress going on, and it is a start, and I did attend the Human Rights Commission meeting and I know that Mr. Dabrowski brought up some of the issues that were established there, and he did participate. I like what I heard, and I recognize that it is a start. My philosophy is "Let's let them do their work, they are going to report back to us, and

then we'll take it from there." The last part is just my opinion. Thank you Council President. I guess that's all.
