

## NOTICE TO ALL POTENTIAL FLEA MARKET FOOD VENDORS

In order to ensure the integrity of all foods sold to the public at a flea market setting, the Woodbridge Health Department is directing all potential Food Vendors to do the following, PRIOR to conducting any flea market food vending:

1. Fill out the attached flea market food vendor application form.
2. Return the completed application form to the Health Department.
3. After our review of the application, we will contact you to schedule a pre-operational inspection.
4. Upon satisfactory completion of the pre-operational inspection, you will be eligible to purchase a required flea market food-vending license at which point you can begin selling limited types of food items (see below).

**Selling foods to the public without completing the required application, inspection and licensing procedures noted above will result in an immediate closure of any food vending operation and a court summons with a fine potential of \$1,000.00.**

### STANDARDS FOR SELLING FOOD AT FLEA MARKETS

- Foods for sale shall be limited to pre-packaged, non-potentially hazardous and/or raw produce items. No meats, fish or dairy items. (Exceptions to this are separately licensed mobile food trucks.)
- All above noted foods shall come from approved and verifiable sources.
- Said food items shall be protected at all times from unnecessary handling and shall be stored and displayed so as to be protected from contamination.
- Said foods shall be stored at least six (6) inches off the ground or floor.
- Cans which are leaking, bulging, rusted or dented are prohibited from sale.
- All food vendors shall maintain clean hands and outer garments.
- Health Department License and Inspection Posting must be visibly posted at all times of operation.
